

“\$1840 Free Fuel” COMPETITION TERMS & CONDITIONS

By entering AA Tourism’s “\$1840 Free Fuel” competition, you are agreeing to the following terms and conditions:

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

2.1 Subject to clause 2.2, entry is open to all residents of New Zealand.

2.2 Directors, management, employees and their immediate families of New Zealand Automobile Association and their associated agencies and companies are not eligible to enter.

2.3 Winners must be 18 years or over to redeem this prize package.

3. HOW TO ENTER

3.1 The Competition commences on Monday 23 January, 2012 at midnight (NZDT) and concludes on Monday 30 January, 2012 at midnight (NZDT).

3.2 Any accommodation booking made on aatravel.co.nz between 23 January – 30 January will be entered into the draw to win \$1840 worth of free fuel.

3.3 One entry per total booking (not per night booked) will be entered into the draw to win.

3.4 Any accommodation booking made with an AA Smartfuel property on aatravel.co.nz between 23 January – 30 January 2012 will earn 25¢ per litre off the first 50 litres of fuel. The ¢pl discount that is loaded onto the customers card is based on the time the accommodation booking was made. The ¢pl discount will be loaded onto the customers AA Smartfuel card one day ahead of the check-in date.

4. PRIZES

4.1 There will be 1 prize winner.

4.2 Total prize value is to a maximum of NZ\$1840 inc. GST.

4.3 On the first day of each month for 18 months, starting from March 1, 2012, your AA Smartfuel account will be credited with \$100 worth of free fuel – this equates to \$2 off per litre up to 50litres at a Participating Redemption Party – if you’re not an AA Member or AA Smartfuel card holder already, we will provide you with a AA Smartfuel card which you will need to register to receive your reward.

- 4.4 AA Smartfuel Discounts may be redeemed by presenting your AA Smartfuel Card when you purchase fuel products at a Participating Redemption Party. The Fuel products for which AA Smartfuel Discounts can be redeemed may or may not include automotive LPG at the election of the relevant Participating Redemption Party and as agreed with us. When you redeem your AA Smartfuel Discounts, the AA Smartfuel Discounts in your AA Smartfuel Account will automatically be applied to Fuel you purchase up to a maximum of 50 litres unless the Participating Redemption Party gives you the option, and you elect, not to redeem those AA Smartfuel discounts on that Fuel purchase. Some Participating Redemption Parties may not be in a position to offer you that option. Following each redemption transaction, the balance of AA Smartfuel Discounts in your AA Smartfuel Account will be reset to nil (whether or not all AA Smartfuel Discounts accrued in your AA Smartfuel Account were utilised in that transaction).
- 4.5 If the AA Smartfuel Discounts in your AA Smartfuel Account are less than the actual pump price of the Participating Redemption Party you will pay:
- (a) the difference between your AA Smartfuel Discounts and the actual pump price for the volume of Fuel you purchase up to a maximum of 50 litres; and
 - (b) the actual pump price for any volume of Fuel you purchase in excess of 50 litres.
- 4.6 If the AA Smartfuel Discounts in your AA Smartfuel Account equals or exceeds the actual pump price of the Participating Redemption Party, you will pay the actual pump price for any volume of Fuel you purchase in excess of 50 litres.
- 4.7 AA Smartfuel Discounts have no cash or negotiable value.
- 4.8 AA Smartfuel Discounts expire at the end of the month following the month in which they are earned.
- 4.9 In participating in the Prizes, the Winner agrees to participate and co-operate as required in all editorial activities relating to the Competition, including but not limited to being interviewed and photographed. The Winner agrees to grant the Promoter a perpetual and non-exclusive license to use such footage and photographs in all media worldwide and the Winner will not be entitled to any fee for such use.

- 5.1 Any accommodation booking made on aatravel.co.nz between 23 January – 29 January in accordance with these Terms and Conditions will be entered into the random draw. The first entrant randomly drawn from the pool of entrants will be the Winner.
- 5.2 AA Tourism's decision (including any decisions as to prize distribution) is final and AA Tourism will not enter into correspondence regarding the result.
- 5.3 It is a condition of accepting the prize that the Winner may be required to sign a legal release in a form determined by the Promoter in its absolute discretion.
